



Average annual consumption of 45 millions of papers. According to the law, documents must be archived for 10.5 years. There was possibility of forging of documents.







- ✓ Due to above mentioned since 1997 implementation of ASYCUDA system stared in IRICA.
- ✓ ASYCUDA only covered exportation & importation procedures and ASYCUDA world added Transit in10 customs.
- ✓ Due to some limitation IRICA decided to implement its national system(Integrated Customs System) since 2013
- ✓ by implementing ICS data entry via pre-declaration is possible at any time of the day.




implementation of ICS


